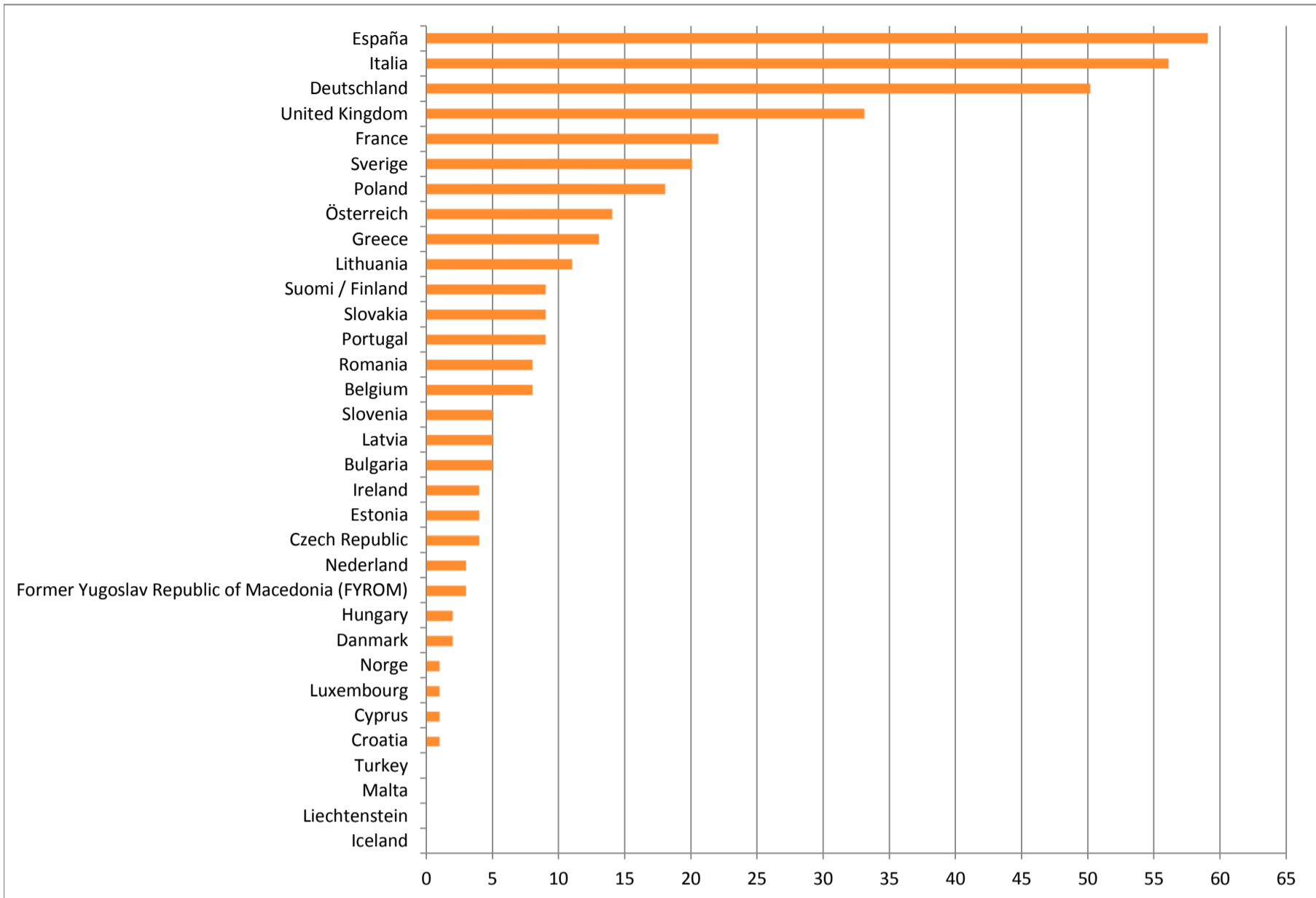

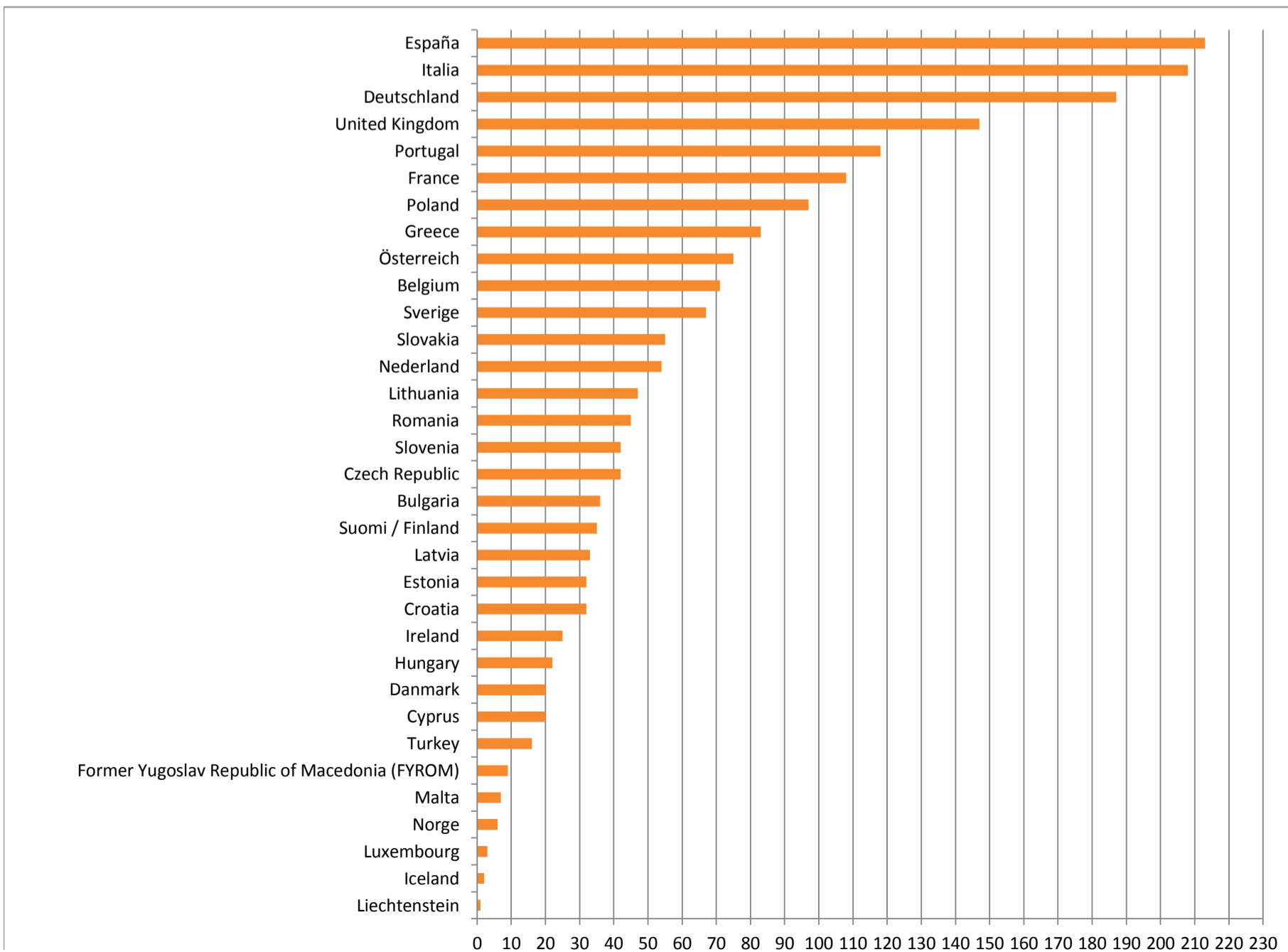

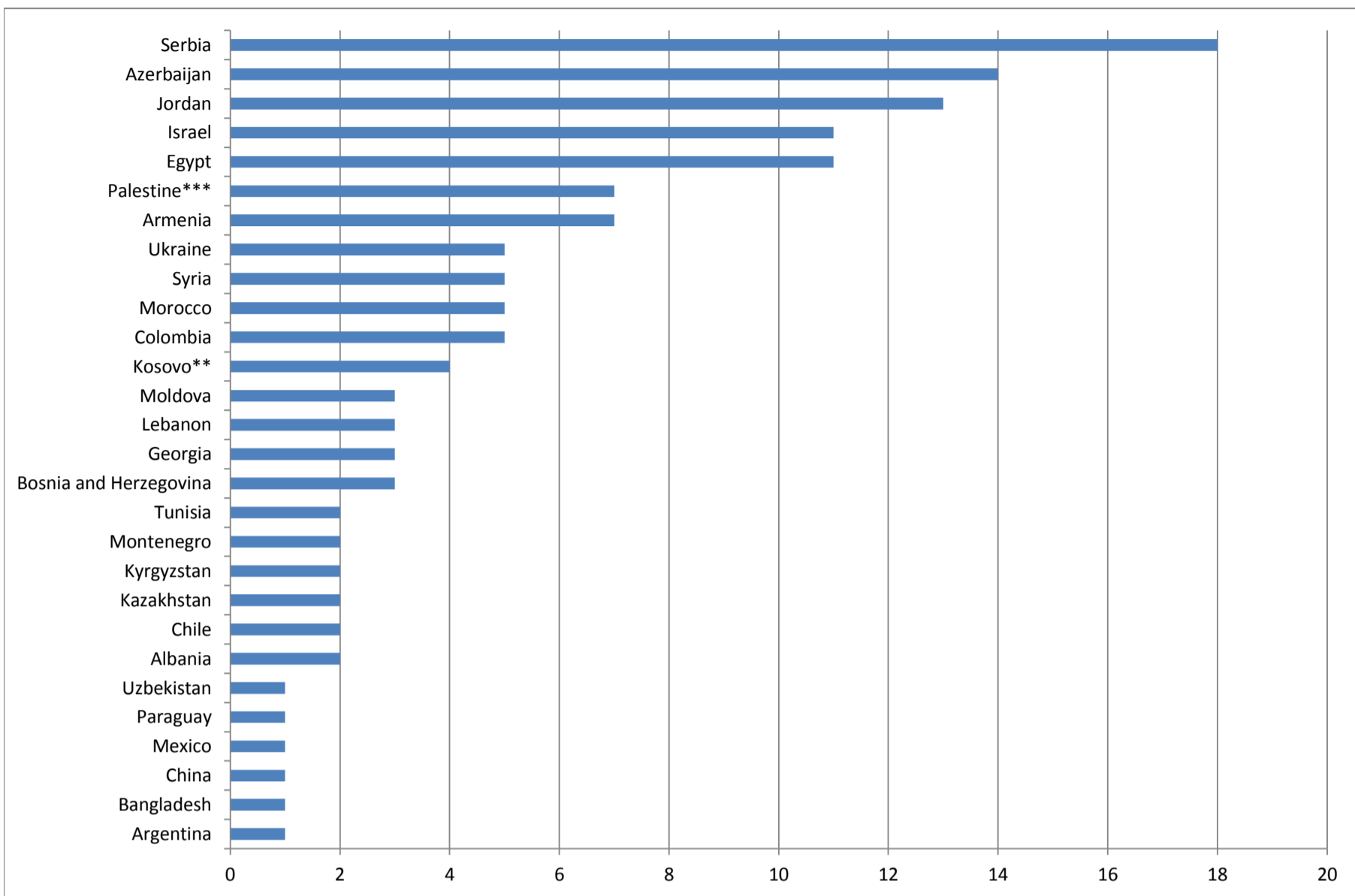
**Ranking by number of application from Programme Countries**
